COLLECTION SCOPE

The Library welcomes donated books and manuscripts that enhance its collections in support of our teaching and research needs. The Archive also welcomes gifts of bookbindery equipment and tools as required by the needs of the collection. See our wanted list for our current needs.

The Library and Archive will decline offers of gifts if they unnecessarily duplicate existing holdings, if the subject matter is outside the scope of its collections, or if there are donor restrictions the Library/Archive cannot honor. See section below regarding acquisition guidelines.

The American Bookbinders Museum is a non-profit 501(c)(3) organization. The fair-market value of any donation is tax-deductible.

For every donation, the museum will provide a letter stating what the gift was and when it was received by the museum. The donor should keep this letter as a receipt of gift in case they are asked to produce it by the IRS.

The Museum does not appraise materials for tax purposes, but can recommend a list of appropriate appraisers who may assist you.

Acquisition Guidelines

The following donations will generally be *refused* as inappropriate to the Museum's needs:

- Materials that are not in good physical condition, e.g., containing mold or mildew, tears, stains, water damage or are in any way impaired in a manner that results in limited or restricted use. Moldy materials are potentially harmful to existing collections.
- Materials that require significant restoration or conservation or unique storage conditions, <u>unless</u> accompanied by appropriate funding.
- Gifts on which a donor places restrictions that will negatively affect access to and use of the materials.
- Single issues of periodicals or broken runs of bound periodicals, unless they fill gaps in our current collection.
- Materials that duplicate current holdings.
- Photocopies/facsimiles of original materials.
- Oversized equipment or artifacts.
- Items outside the scope of our collection areas.
